In the event of non-receipt of email/sms, candidates are advised to report for the medical examination at the declared venue with their interview call letter/email intimation copy.

The final selection/appointment would be subject to satisfactory medical report and verification of certificates pertaining to age, qualification, experience, caste certificate (in case of reserved category candidates)/disability certificate (in case of "Persons with Disability" candidates), Medical Council of India registration certificate/State Medical Council registration certificate etc.

No travelling expenses will be paid for the medical examination.

No communication shall be entertained from candidates whose names do not appear in the list.

In case the candidate fails to report for medical examination as indicated above, we shall assume that he/she is not interested in joining the company and his/her candidature shall stand cancelled automatically without any reconsideration of the same in future and without any further communication to him/her.
