Re: Notice for Withdrawal of 'Top Up Medicare Policy' with effect from 1st October, 2020

Dear Madam/Sir,

Greetings from United India!

Hope you and your family are keeping in good health. At the outset, we wish to thank you for your continuous support and association with United India. We value you highly as our loyal customer and are always keen to serve you in the most professional manner and strive to offer the latest innovations in the area of health insurance.

We would like to bring to your kind attention that the **Top Up Medicare Policy**, under which you are currently covered, shall be withdrawn with effect from **1st October 2020**; this means it will no longer be available for renewal after the said date. This notice is hereby served for your information.

We want to stress that we have deliberated long and hard about this decision to withdraw, keeping in mind the welfare of our customers, and we outline below the reasons for the same:

1. The product has been consistently registering low volume in sales and based on our extensive market research and customer/ intermediary feedback, we find that the demand for this product is generally low.
2. United India currently offers a nearly similar product titled "**Super Top Up Medicare Policy**" which provides better coverage and is available, for purchase, to all our customers.

OPTIONS FOR YOU

In case, your renewal is due between 01.07.2020 to 30.09.2020, at the time of renewal, you shall be provided an option of renewing your Top Up policy at existing terms, conditions, and premium rates for only one more year. **No subsequent renewals shall be permitted** as the product ceases to exist w.e.f. 1st October 2020.

Alternatively, you have an option to migrate to our other similar product '**Super Top Up Medicare Policy**' at an equal Sum Insured. Please note that after migration to Super Top Up Medicare Policy, the premium rates, guidelines and policy terms and conditions of Super Top Up Medicare Policy shall be applicable to you. Suitable credit of continuity/waiting periods for all the previous policy years would be extended in the new Super Top Up policy, provided your existing Top Up policy has been maintained without a break.

In case, your renewal is due after 1st October 2020, you have to necessarily migrate to our '**Super Top Up Medicare Policy**' at an equal Sum Insured as the product ceases to exist from 1st October 2020.
