. A person who has not committed any breach of professional or other misconduct;
i. Not an Appointed Actuary or an Actuary in addition to Appointed Actuary of another Insurer in ndia;
ii. A person who possesses a Certificate of Practice issued by the Institute of Actuaries of India;
iii. Not over the age of 60 years.
