### PRE-QUALIFICATION TENDER (PQT) – SUPPLY AND SUPPORT OF UNINTERRUPTED POWER SUPPLY (UPS) SYSTEMS.

United India Insurance Company Limited proposes to empanel vendors for a period of three years for supply and support of UNINTERRUPTED POWER SUPPLY (UPS) SYSTEMS throughout India as and when the need arises. The Vendors meeting the following criteria may apply for empanelment in the specified format.

#### **ELIGIBILITY CRITERIA:**

- a. The vendor is registered as a company in India as per Companies Act, 1956. The Certificate of Incorporation issued by the Registrar of Companies is to be submitted. (Documentary proof should be attached).
- b. The Vendor should be original equipment manufacturer (OEM) for UPS Systems or premium partner / authorized reseller of the UPS Systems in India.
- c. The Vendor should have an Average Annual Turnover of Rs.25 Crores (Rupees Twenty-Five Crores only) in the last three financial years (FY 2015-16, 2016-17 and 2017-18) and this not inclusive of the turnover of associate companies as per the audited accounts. Financial year shall mean an accounting period of 12 months. Figures for an accounting period exceeding 12 months will not be acceptable. Annual reports of FY 2015-16, 2016-17 and 2017-18 should be attached. Vendors who are yet to publish their audited document for the year 2017-18, must submit the provisional/CA certified results for the FY 2017-18. (Documentary proof should be attached).
- d. The vendor has registered positive net profit (after tax) in at least one year in the last three Financial Years (2015-18). Financial year shall mean an accounting period of 12 months. Figures for an accounting period exceeding 12 months will not be acceptable. Vendors who are yet to publish their audited document for the year 2017-18, must submit the provisional/CA certified results for the FY 2017-18. (Documentary proof should be attached).
- e. Should have manufactured, sold and serviced UPS systems for 5 years or more.
- f. Should have manufacturing unit within India and maintain sufficient spares for the entire range of UPS systems.
- g. Should have the capacity to manufacture up to 100 KVA UPS systems.
- h. Should possess valid <u>ISO 9001:2000</u> or higher certification for manufacturing of UPS Systems.
- Should have executed <u>at least one major order</u> in the BFSI (Banking, Financial Services and Insurance) segment with purchase order value of not less than <u>Rs. Seventy-Five Lakhs</u> for UPS during the last three financial years.
- j. Should have executed at least one single order during the last 3 years for supply, installation and support of UPS in more than 50 Locations/ offices in India.
- k. The Vendor should have countrywide support service facilities (Owned / Franchise / Resident Engineer) at least in 50 different locations in Metro/City/Town/village including locations where UIIC has its Regional Offices. Of the 30 regional office locations, the vendor should have service centres in at least 25 regional office locations (List of our Regional Office locations is given separately). (It may be noted that if a Vendor is having more than one service center in a location, the same shall be treated as one location only.)

I. The vendor should not be black listed at the time of PQT application by any Central Government/State Government / PSU / Banking / Insurance company in India. Vendor to submit the Self Declaration certificate.
